The Cobb County Board of Commissioners will receive bids for the construction of **South Parallel Taxiway Extension – Phase 3 and North Apron Improvements – Phase 3** project at the Cobb County Airport. All bids will be received until noon on Thursday, October 14, 2004 at the Cobb County Purchasing Department, 1772 County Services Parkway, Marietta, GA 30008. No bids will be accepted after the noon deadline. Those received late will be returned unopened.

Bids will be opened at 2:00 p.m. on Thursday, October 14, 2004 at the Cobb County Purchasing Department, 1772 County Services Parkway, Marietta, GA 30008.

The work is generally described as follows:

Schedule 'A': South Parallel Taxiway Extension – Phase 3

Construction of approximately 2,600 linear feet of bituminous taxiway pavement, including approximately 18 acres of clearing and grubbing, approximately 70,000 cubic yards of embankment formation, approximately 1,900 linear feet of storm sewer installation, approximately 2,600 tons of bituminous paving, and approximately 8,000 linear feet of taxiway edge light cabling, as well as pavement marking, erosion control measures, and grassing.

Schedule 'B': North Apron Improvements – Phase 3

Construction of approximately 14,900 square yards of apron pavement and connecting taxiway, including approximately 100 linear feet of storm sewer installation, and approximately 2,900 tons of bituminous paving, as well as pavement marking, erosion control measures, and grassing.

A Pre-Bid Conference will be held at 10:30 a.m. on September 30, 2004 at Cobb County Airport in the conference room of Northside Aviation, Entrance B, 1723 McCollum Parkway, Kennesaw, GA 30144. **Bidders are strongly encouraged to attend the Pre-Bid Conference.**

Bid security in the form of a bid bond equal to 5% of the total bid is required. Contract security in the form of 100% Performance and Payment Bonds will be required

No bid may be withdrawn after closing time for the receipt of proposals for a period of ninety (90) days.
