The work consists of

INSTALLATION OF AIRPORT PERIMETER FENCING

(Including approximately 10,000 linear feet of 6-foot chain link fence with associated gates and one manually operated ornamental cantilever entrance gate)

at the Cobb County – McCollum Field, Marietta, Georgia.

IMPORTANT NOTICE TO BIDDERS

A prebid meeting is scheduled for **10:00 a.m. on Tuesday, February 7, 2006**, at the Northside Aviation Terminal Building at Cobb County Airport, 1723 McCollum Parkway, Kennesaw, GA 30144 located at the end of Entrance B. All prospective bidders are encouraged to attend.

Prospective bidders should read the following instructions carefully before submitting their bids. For each item on the proposal there is a space provided for the unit price to be shown in numerals. At the extreme right of this section another space is provided for the total of extension of each particular item in dollars and cents. Extensions of the various items must be subtotaled, carried forward and shown as a grand total following the last proposal item. ALL NOTATIONS MUST BE IN INK.

A Bidder's bond must be executed on the form furnished by the Owner, and the required bond, cash, cashier's check, or certified check must accompany each proposal, in the amount of five (5%) percent of the total amount of the proposal. All bonds must be countersigned by a Georgia Resident Agent.

A 100% performance bond and 100% payment bond will be required of the contractor at time of contract execution. The bonding company must have a Georgia resident agent.

All work under the contract shall be completed within **SIXTY (60) calendar days** from the issuance of the notice to proceed. Liquidated damages for delay in completion will be **Two Hundred Dollars (\$200.00) per day**.
