The Contract, if awarded by Cobb County, will be on the basis stated in the Instructions to Bidders. No bid may be revoked or withdrawn prior to November 26, 2007 after bid opening.

A Bid Bond, cashier's check or certified check made payable to Cobb County / Turner Construction Company in the amount equal to five percent (5%) of the submitted base bid price must accompany each submitted bid.

Cobb County will not provide any bonds. The successful bidder, upon approval, will be required to submit to Turner Construction Company, a Labor and Materials Payment Bonds acceptable to Turner Construction Company, each in an amount equal to one-hundred percent (100%) of the contract price, and executed by a surety company licensed to do business in the State of Georgia and listed in the Department of the Treasury Circular 570, latest edition. The surety

company shall have an A.M. Best Company minimum rating of "A" with a financial size of VII "7" or better. Performance and Labor and Materials Payment Bonds shall name Turner Construction Company as an additional
