Written responses to all inquiries received by 5:00 PM, Thursday, March 27, 2008 will be mailed or faxed to all bidders on record with the Cobb County Purchasing Department as having been issued the Bid Package. No other County staff or officials associated with the Project should be contacted regarding this Bid Package. Doing so may result in disqualification.

The Contract, if awarded by Cobb County, will be on the basis stated in the Instructions to Bidders. No bid may be revoked or withdrawn prior to May 30, 2008 after bid opening.

Cobb County will not provide any bonds. The successful bidder, upon approval, will be required to submit to Turner Construction Company, a Labor and Materials Payment Bonds acceptable to Turner Construction Company, each in an amount equal to one-hundred percent (100%) of the contract price, and executed by a surety company licensed to do business in the State of Georgia and listed in the Department of the Treasury Circular 570, latest edition. The surety

company shall have an A.M. Best Company minimum rating of "A" with a financial size of VII "7" or better. Performance and Labor and Materials Payment Bonds shall name Turner Construction Company as an additional named obligee, and must

be accompanied by a letter stating the bonding company's current rating for verification prior to acceptance by Turner Construction Company.

Cobb County and Turner Construction Company reserves the right to award a contract on whatever basis is in the best interests of the Project and Cobb County, and to accept or reject any or all bids and to waive technicalities and informalities.
