Bidding documents will be forwarded upon receipt of a non-refundable fee of **\$30.00** for each set of black and white. All checks shall be payable to Professional Design Group.

Proposals must be accompanied by Bid Security, in a form as allowed by law, in the amount not less than five percent (5%) of the Base Bid. Performance Bond and Labor and material Payment Bond, each in the amount equal to 100% of the contract sum will be required of the successful bidder or other form as allowed by law. Bonds must be submitted on AIA forms listed in the Project Manual and must be written by a surety company licensed to do business in the State of Georgia, have a Best's rating of "A" or better, appear on the current U.S. Treasury Department List of Sureties that are acceptable on bonds for the Federal Government (Circular 570), and have recommended bond limits equal to or in excess of those required for this Project; or otherwise acceptable to the Owner.

No bid may be withdrawn for a period of sixty (60) calendar days after date of bid opening, unless otherwise specified. The competency and responsibility of bidders will be considered by the Owner in making the award. The Board of Commissioners reserve the right to reject any and all bids, to waive any informalities, to reject portions of the bid, to waive technicalities and to award contracts in a manner consistent with the best interest of the owner and the laws of the State of Georgia.
