SCOPE OF SERVICES

Cobb County seeks a Contractor that will provide a Full Service Maintenance Agreement to Inspect, Service, Repair, Rebuild and Maintain Electrical/Mechanical and Electronic Equipment such as but not limited to motors, drives, gearboxes, pumps, generators, breakers, transformers, blowers, electronic boards, switchgears, VFD's, PLC's, etc. This includes the Cobb County Water System Water Reclamation Facilities, Lift Stations, Fresh Water Pump Stations, and other locations as requested. Personnel from various locations will direct the Work activities of the Contractor.

Bids are due at the Cobb County Purchasing Department, 1772 County Services Parkway, Marietta, GA 30008 before 12:00 Noon on October 27, 2011. Late bids will not be accepted.

A pre-bid meeting will be held at the offices of the Cobb County Purchasing Department, 1772 County Services Parkway, Marietta, Georgia on October 12, 2011 at 10:00 a.m. Vendors are encouraged to attend.

CONTRACT TERM and PRICING

Contract awarded as a result of bids submitted under this Sealed Bid shall extend from the date of award for a period of 12 full months.

Prices shall remain firm for the duration of the initial Contract period. Reasonable price changes based on market conditions and price/cost analysis may be made after the initial Contract period. The Contractor shall supply documentation satisfactory to Cobb County, such as: documented changes to Producers Price Indexes; Consumer Price Indexes; or a manufacturer's published notification of price change(s).

Cobb County will evaluate this information to determine if revising the pricing is considered fair and reasonable to the satisfaction of Cobb County. Requests for any such change must be received in writing by the Cobb County Purchasing Department thirty (30) days prior to the expiration of the original contract term. The County may cancel the contract if the price increase request is not approved.

All price reductions at the manufacturers' or distributors' level shall be reflected in a reduction of the contract price(s) to Cobb County retroactive to the effective date of the price reduction(s).

Contract is renewable, at the option of Cobb County Government, and upon written agreement by the vendor. However, the total duration of this contract, including the exercise of any options, shall not exceed three (3) years (basic year and two (2) one (1) year options).

GENERAL REQUIREMENTS

A. EXAMINATION OF WORK SITES

Each Contractor shall fully inform himself as to the existing conditions and limitations under which the Work is to be performed. No allowances will be made to a Contractor due of lack of such examination or knowledge. The submission of a bid will be considered as conclusive evidence that the Contractor has made such examination.

B. PROOF OF COMPETENCY

Although a Qualification Statement is not required, additional evidence satisfactory to Cobb County may be requested to provide sufficient means and experience in the types of Work called for to assure the completion of Work requested in a satisfactory manner as detailed in this agreement. Contractor may be required to supply a list of equipment held by the Contractor to support the services that the Contractor intends to provide to Cobb County. If the Contractor cannot provide satisfactory evidence of the Contractors' ability to perform the work requested as defined in this agreement, Cobb County may terminate this agreement. Cobb County has the right to visit Contractor's workshop, warehouse, or facility.

C. WORK

Cobb County seeks a Contractor who shall perform and furnish all labor, supervision, materials, equipment, tools, scaffolds, transportation, storage and all other things necessary to execute and complete all Work identified and described herein, or which can be reasonably inferred. Contractor shall perform the Work in a good and workmanlike manner strictly in accordance with this agreement.

Cobb County shall have the right to inspect the Work of the Contractor to determine compliance with this agreement in conjunction with payments. This inspection is not intended to provide intelligence to the Contractor and in no way will this inspection relieve Contractor of responsibility of knowledge ability of the status of the Work.

Contractor represents and agrees that they have carefully examined and understand this agreement relevant to the Work; has adequately familiarized themselves with conditions affecting the difficulty of the Work; and has entered into this agreement based on their examination, investigation, and evaluation and not in reliance upon any opinions or representations of Cobb County.

D. PAYMENT CONDITIONS:

Contractor shall, as often as requested by the County, furnish such information, evidence, and substantiation as the County may require with respect to the extent and value of current progress and the nature and extent of all obligations incurred by Contractor in connection with the Work and all payments made by Contractor. Contractor shall also furnish, as required by the County in its sole discretion, such partial or formal lien waivers or releases as the County deems necessary to ensure that Contractor has paid all persons furnishing labor, material, or services in furtherance of any Work furnished hereunder. If required by the County, the furnishing of such lien waivers and releases shall be a condition precedent to any payment hereunder. Nothing herein shall constitute any requirement that the County require such releases and waivers shall limit the County's right to require them subsequently.

The County reserves the right to withhold, as an additional reserve and without limiting its other rights and remedies, an amount sufficient:

- 1. to defend, satisfy and discharge any asserted claim that Contractor (or anyone providing any of the Work hereunder) has failed to make payment for labor, services, materials, equipment, taxes, or other items or obligations furnished or incurred in connection with the Work or has caused damage to the Work or to any other Work on the jobsite;
- 2. to complete the Work if it appears that funds remaining in the contract, including retainage, and exclusive of back charges, are insufficient to complete the Work;
- 3. to reimburse the County for any back charges incurred as a result of any act or omission by Contractor hereunder;
- 4. to protect the County from the possible consequences of any other breach or default by Contractor hereunder; or
- 5. to secure the County with respect to any breach or default by Contractor or its affiliates, parent company and subsidiaries under any other agreement. Payment hereunder shall not be evidence of the proper performance or progress of the Work and no payment shall be construed to be acceptance of defective, faulty, or improper Work or materials.

Contractor shall invoice Cobb County Finance for payment on a monthly basis. Any Work invoiced for payment ninety days after completion will require a letter of explanation as to the reason for the delay. All Work performed in August must be invoiced by October 1st. All Work performed in September must be invoiced and received by Cobb County within the first two (2) weeks of October.

E. ASSIGNMENT

Contractor shall not assign this agreement or monies due or to become due hereunder without the prior written consent of the County. No assignment by Contractor of any right hereunder shall be effective and any such attempt shall be null and void. No third party shall have any right to enforce any right of the Contractor under this agreement. If the County gives written consent to an assignment of this agreement, in whole or part, Contractor shall not be relieved of its duties and obligations hereunder and shall be and remain fully responsible and liable for the acts of and omissions of its assignees. Nothing herein shall prevent Contractor from engaging subcontractors to perform a portion of the Work hereunder. However, Contractor shall be and remain as fully responsible for all persons directly or indirectly employed by such subcontractors, as Contractor is for its own acts and omissions of and those of its agents, servants, and employees. Additionally, nothing herein shall prevent any guarantor or surety of Contractor from enforcing any right hereunder after acknowledgement of its obligation as guarantor or surety. Any attempted enforcement of such rights in the absence of an express acknowledgement shall constitute an admission by any guarantor surety of its obligations under its agreement of guarantee or surety ship.

F. COMPLIANCE

Contractor shall, at their expense, obtain all necessary licenses and permits pertaining to the Work and comply with all statues, ordinances, rules, regulations and orders of any governmental or quasi-governmental authority having jurisdiction over the Work or the performance thereof, including, but not limited to, those relating to safety, wages, discrimination, and equal employment opportunity. Contractor shall promptly correct any violations of such statues, ordinances, rules, regulations, and orders committed by Contractor, its agents, servants, and employees. Contractor shall receive and respond to, and shall defend, indemnify and save harmless Cobb County, as well as anyone to whom Cobb County is obligated, and their agents, servants and employees from and against any loss, liability, or expense arising from any such violations, citations, assessments, fines, or penalties.

G. SAFETY

Contractor agrees that the prevention of accidents to persons engaged upon or in the vicinity of the Work is their responsibility. Contractor shall implement safety measures, policies, and standards conforming to those required or recommended by governmental or quasi-governmental authorities having jurisdiction.

H. JOB SITE CLEAN UP

Contractor shall, at their expense:

- 1. Keep the premises at all times free from waste materials, packaging and other debris accumulated with the Work by collecting and removing such debris from the job site on a daily or more frequent basis or as requested by the County.
- 2. Upon completion of the Work in each area, sweep and otherwise make the Work area in its immediate vicinity "broom clean".
- 3. Remove all tools, equipment, scaffolds, temporary structures and surplus materials as directed by the County at the completion of the Work; and
- 4. Conduct a final inspection of job site for acceptance by the County. Contractor agrees to provide all cleaning and cleanup required under this agreement pertaining to the Work to the extent that such requirements are in excess of those contained in this paragraph.

I. QUALITY

Contractor shall provide first quality materials and workmanship conforming to the requirements of this agreement. Contractor shall provide an opportunity for the inspection of the Work by the County. Upon written notification, the Contractor shall take down and or remove all portions of the Work that the County considers unsound, improper, or in any way

failing to conform to their standards in workmanship or quality. The Contractor agrees to replace the same with proper and satisfactory Work and make good all Work damaged or destroyed. Cobb County's failure to discover or notify Contractor of defective or nonconforming Work and all damages resulting there from does not relieve the Contractor of the responsibility to correct deficiencies.

J. GUARANTEES

Contractor warrants and guarantees their Work fully provided for in and required by this agreement. The Contractor shall, at their expense and by reason of its expressed warranty, make good any faulty, defective, or improperly used or installed parts discovered within one year from the date of acceptance of the Work or within such longer period as may be provided by the manufacturer of the part or parts. Contractor warrants that all materials furnished shall meet the requirements of the manufacturer or the County and impliedly warrants that all parts and materials are both merchantable and fit for the purposes for which they are used under this agreement.

K. DAMAGE

Cobb County shall not be liable or responsible for loss or damage to equipment, tools, vehicles, or other personal property owned, rented, or used by the Contractor, or employed by or through Contractor, during the performance of their Work. Contractor shall maintain such insurance and take such protective action, as Contractor deems necessary with respect to such property. Cobb County shall not be liable or responsible for any loss or damage to Work preformed by Contractor or to the Work of the County or any other contractor, resulting from the Work performed by the Contractor, or its agents, servants or employees hereunder. Contractor shall take all precaution to protect the Work from loss or damage prior to acceptance by the County.

SPECIFIC REQUIREMENTS

- A. SCOPE OF WORK:
 - 1. Contractor shall provide full service maintenance including but not limited to inspections, preventative/predictive maintenance, repairs, rebuilds, refurbishments, and replacements as requested by the County on motors, AC/DC drives, gear boxes, pumps, generators, breakers, transformers, blowers, PC boards, VFD's, soft starts, switchgears, and PLC's.
 - 2. Contractor shall provide emergency and holiday service as requested by the County within a maximum response time of two hours.
 - 3. Electrical work shall be performed by the direct supervision of an electrician with a current State of Georgia electrical license.
 - 4. Contractor shall adhere to applicable Federal, State, and local safety codes. Lock out/tag out and confined space entry procedures must be strictly enforced.
 - 5. Contractor shall conform to all applicable Federal, State, and local codes, as well as all other applicable code requirements, such as;
 - a. Cobb County and State of Georgia Electrical Codes
 - b. National Electrical Codes (NEC)

- c. Rules of the Electric Utility
- d. Life Safety Code 101
- e. NECA Standard of Installation
- f. National Fire Protection Association (NFPA)
- 6. Contractor shall be required to announce their arrival and departure with the maintenance supervisor of the location in which the Work will be performed prior to and after completion of all Work.
- 7. Contractor must sign in and out on the log sheet provided at each facilities administrations building.
- 8. Contractor must obtain consent from the maintenance or the operations supervisor prior to any Work while on site, no exceptions. Contractor must log name of person authorizing the same on their service report.
- 9. Contractor shall be required to provide a copy of all invoices received for materials as proof of purchase.
- 10. All rates shall include mileage, labor, equipment, and tools of the trade.
- 11. Contractor shall provide to the maintenance supervisor a service report or preventative maintenance report for each piece of equipment, such as a motor or drive, upon completion of Work.

B. ANNUAL PREVENTATIVE MAINTENANCE INSPECTIONS

- 1. Contractor shall provide planned preventative maintenance visits on a routine basis as agreed upon by Cobb County.
- 2. Contractor shall maintain a PM history and documentation of all equipment serviced.
- 3. Contractor shall track and maintain a preventative maintenance database for planned preventative maintenance visits and provide to Cobb County.
- 4. Contractor shall perform scheduled preventive maintenance tasks, such as checking, cleaning, and repairing equipment, to detect and prevent problems for equipment designated by Cobb County.
- 5. Contractor shall perform testing and inspection of motors, blowers, switchgear, breakers, tiebreakers, transformers, generators, pumps, and other equipment as requested.
- 6. Contractor shall calibrate instruments and equipment to prescribed specifications.

C. IN FIELD SERVICES

Contractor shall perform field service repairs that consist of multiple facets of disciplines associated with motors, drives, pumps, generators, transformers, etc. to include alignment, mechanical and laser, services.

D. SHOP SERVICES

Shop services may be required when repairs cannot be performed in the field. Contractor shall:

- 1. Provide transportation of equipment to and from shop for repairs
- 2. Provide all necessary tools and equipment to repair motors, drives, gearboxes, pumps, generators, breakers, transformers, blowers, electronic boards, switchgears, VFD's, PLC's, etc. which may consist of the following:
 - a. Complete disassembly and assembly

- b. Clean up and inspection of all components
- c. Installation of new components
- d. Burnout
- e. Curing
- f. Vacuum pressure impregnation
- g. Dip tanks
- h. Coil winding
- i. Lamination repair/replacement
- j. Rotor repair/replacement
- k. Load Testing
- l. Balancing
- m. Alignment, mechanical and laser
- n. Reface, ream, polish, and machine parts to specified tolerances.

E. REMOVAL, TRANSPORTATION, AND REINSTALLATION

This agreement shall include all facets of dismantling, pulling, transporting to and from, and reinstalling equipment on-site, to, and from Contractors local shop.

F. PARTS AND MATERIALS

Contractor shall provide parts and materials for motors, AC/DC drives, gear boxes, pumps, generators, breakers, transformers, blowers, PC boards, VFD's, soft starts, switchgears, PLC's, to complete Work.

G. MOBILE SERVICE

Contractor shall provide a fully equipped mobile workshop for emergency and non-emergency on-site repair and or refurbishment of equipment.

H. GENERAL SERVICES

The Contractor shall perform the following and additional services as requested by Cobb County:

- 1. Assemble electrical parts, such as alternators, generators, starting devices, and switches.
- 2. Reassembles repaired electric motors to specified requirements and ratings.
- 3. Reassemble and test equipment after repairs.
- 4. Repair and rebuild defective mechanical parts in electric motors, generators, and related equipment.
- 5. Wind new coils on armatures of generators and motors.
- 6. Rewind coils on core while core is in slots, or makes replacement coil, using coil-winding machine.
- 7. Install coils.
- 8. Inspect and test electric meters, relays, and power, to detect cause of malfunction and inaccuracy.
- 9. Rewire electrical systems and repair or replace electrical accessories.
- 10. Install, secure, and align parts.
- 11. Replaces defective parts, such as coil leads, carbon brushes, and connecting wires.

- 12. Tests for overheating.
- 13. Locate, remove, and repair circuit defects such as blown fuses or malfunctioning transistors.
- 14. Set up and test equipment to ensure that it functions properly.
- 15. Test faulty equipment to diagnose malfunctions of electronic units and systems.
- 16. Repair and adjust equipment, machines, and defective components, replacing worn parts such as gaskets and seals in watertight electrical equipment.
- 17. Inspect components of industrial equipment for accurate assembly and installation and for defects such as loose connections and frayed wires.

- 22. Open and close switches to isolate defective relays; then perform adjustments or repairs.

- 24. Disconnect voltage regulators, bolts, and screws, and connect replacement regulators to high-voltage lines.
- 25. Maintain inventories of spare parts for equipment, requisitioning parts as necessary.
- 26. Solder, wrap, and coat wires to ensure proper insulation.
- 27. Replace broken and defective parts.
- 28. Cut insulating material to fit slots on armature core and place material in bottom of core slots.
- 29. Tests armatures and motors to ensure proper operation.
- 30. Splice and connect cable from meter or current transformer to pull box or switchboard to provide power.
- 31. Coordinate all work with Cobb County facility supervisors.
- 32. Consult with Cobb County supervisors and engineers to plan layout of equipment and to resolve problems in system operation and maintenance.
- 33. Disassemble, dismantle equipment, and take to specialized repair shop for repair.
- 34. Install repaired equipment.
- 35. Determine feasibility of using standardized equipment, and develop specifications for equipment required to perform additional functions.
- 36. Develop or modify industrial electronic devices, circuits, and equipment according to available specifications.
- 37. Records repairs required, parts used, and labor time.
- 38. Grinding, welding, and replacement of parts and to machine parts as needed.
- 39. Full range operational checks
- 40. Provide technical support, engineering services, and training services as requested
- I. TRAINING SERVICES

Minimum of two (2) eight (8) hour classes covering at a minimum topics such as troubleshooting electrical and electronic equipment, preventative maintenance, electrical safety and current safety regulations. Classes are to be accomplished within 90 days of

implementation of the contract.

Cobb County General Instructions for Bidders, Terms and Conditions

I. Preparation Of Bids

Each bidder shall examine the drawings, specifications, schedule and all instructions. Failure to do so will be at the bidder's risk, as the bidder will be held accountable for their bid response.

Unit price for each quotation shall be shown and such price shall include packing unless otherwise specified, along with a total and grand total where applicable. In case of discrepancy between a unit price and extended price, the unit price will be presumed correct.

Each bidder shall furnish all information required by the bid form or document. Each bidder shall sign the bid and print or type his or her name on the schedule. The person signing the bid must initial erasures or other changes. An authorized agent of the company must sign bids.

Invitations to Bid issued by Cobb County are advertised on the Cobb County Internet site (<u>www.purchasing.cobbcountyga.gov</u>) and every Friday in the Cobb County legal organ, the Marietta Daily Journal.

II. Delivery

Each bidder should state the time of proposed delivery of goods or services. Words such as "immediate", "as soon as possible", etc. shall not be used. The known earliest date or the minimum number of calendar days required after receipt of order (delivery A.R.O.) shall be stated (if calendar days are used, include Saturday, Sunday and holidays in the number).

III. Explanation to Bidders

Any explanation desired by a bidder regarding the meaning or interpretation of the invitation for bids, drawings, specifications, etc. must be received by **5:00 pm on October 18, 2011** in order for a reply to reach all bidders before the close of the bid. Any information concerning an Invitation to Bid (ITB) will be furnished to all prospective bidders as an addendum if such information is necessary or if the lack of such information would be prejudicial to uninformed bidders.

The written bid documents supersede any verbal or written communication between parties. Addenda are posted on the Purchasing web site: <u>www.purchasing.cobbcountyga.gov</u>. Receipt of addenda should be acknowledged in the bid. It is the bidder's ultimate responsibility to ensure that they have all applicable addenda prior to bid submittal.

IV. Submission of Bids

Bids shall be enclosed in sealed envelopes, addressed to the Cobb County Purchasing Department with the name of the bidder, the date and hour of opening and the invitation to bid number on the face of the envelope. Bids must be received in the Purchasing Department no later than the date and time (determined by the date/time stamp in the department) set forth in the Invitation to Bid. It is the sole responsibility of the bidder to ensure that his or her bid reaches the Purchasing Department. Telegraphic/faxed bids will not be considered. Any addenda should be enclosed in the sealed envelopes as well. Any addenda should be enclosed in the sealed envelopes as well. Any addenda should be enclosed in the sealed on the Bid Proposal Form. Any revisions made on the outside of the envelope will not be accepted. The bids will be publicly opened and read at the time and place set forth in the Invitation to Bid.

Samples of items, when required, must be submitted within the time specified and, unless otherwise specified by the County, at no expense to the County. Unless otherwise specified, samples will be returned at the bidder's request and expense if items are not destroyed by testing. Items offered must meet required specifications and must be of a quality, which will adequately serve the use and purpose for which intended.

Full identification of each item bid upon, including brand name, model, catalog number, etc. must be furnished to identify exactly what the bidder is offering. The bidder must certify that items to be furnished are new and that the quality has not deteriorated so as to impair its usefulness.

If no items are bid on, the "Statement of No Bid" must be returned, with the envelope plainly marked "No Bid" including the bid number. Where more than one item is listed, any items not bid upon must be indicated "No Bid".

Unsigned bids will not be considered except in cases where bid is enclosed with other documents, which have been signed. The County will determine this.

Cobb County is exempt from federal excise tax and Georgia sales tax with regards to goods and services purchased directly by Cobb County. Suppliers and contractors are responsible for federal excise tax and sales tax, including any taxes for materials incorporated in county construction projects. Suppliers and contractors should contact the State of Georgia Sales Tax Division for additional information. Tax Exemption Certificates will be furnished upon request.

Information submitted by a bidder in the bidding process shall be subject to disclosure after the public opening in accordance with the Georgia Open Records Act. Each page of proprietary information must be identified. Entire bid may not be deemed proprietary.

V. Withdraw Bid Due To Errors

The bidder shall give notice in writing of his claim of right to withdraw his bid without penalty due to an error within two (2) business days (48 hours) after the conclusion of the bid opening. Bids may be withdrawn from consideration if the price was substantially lower than the other bids due solely to a mistake therein, provided the bid was submitted in good faith, and the

mistake was a clerical mistake as opposed to a judgment mistake, and was actually due to an unintentional arithmetic error or an unintentional omission of a quantity of work, labor or material made directly in the compilation of the bid, which unintentional arithmetic or unintentional omission can be clearly shown by objective evidence drawn from inspection of original work papers, documents and materials used in the preparation of the bid sought to be withdrawn. The bidder's original work papers shall be the sole acceptable evidence of error and mistake if he elects to withdraw his bid. If a bid is withdrawn under the authority of this provision, the lowest remaining responsive bid shall be deemed to be low bid. Bid withdrawal is not automatically granted and will be allowed solely at the discretion of Cobb County.

No bidder who is permitted to withdraw a bid shall, for compensation, supply any material or labor or perform any subcontract or other work agreement for the person or firm to whom the contract is awarded or otherwise benefit, directly or indirectly, from the performance of the project for which the withdrawn bid was submitted.

VI. Testing and Inspection

Since tests may require several days for completion, the County reserves the right to use a portion of any supplies before the results of tests are determined. Cost of inspections and tests of any item, which fails to meet specifications, shall be borne by the bidder.

VII. F.O.B. Point

Unless otherwise stated in the Invitation to Bid and any resulting contract, or unless qualified by the bidder, items shall be shipped F.O.B. Destination. The seller shall retain title for the risk of transportation, including the filing for loss or damages. The invoice covering the items is not payable until items are delivered and the contract of carriage has been completed. Unless the F.O.B. clause states otherwise, the seller assumes transportation and related charges either by payment or allowance.

VIII. Patent Indemnity

The contractor guarantees to hold the County, its agents, officers, or employees harmless from liability of any nature or kind for use of any copyrighted or uncopyrighted composition, secret process, patented or unpatented invention, articles or appliances furnished or used in the performance of contract, for which the contractor is not the patentee, assignee or licensee.

IX. Insurance

Insurance requirements: Contractor shall procure and maintain for the duration of the contract, insurance against claims for injuries to persons or damages to property that may arise from or in connection with performance of the Work hereunder by the Contractor, his agents, representatives, employees, or subcontractors.

A. MINIMUM LIMITS OF INSURANCE

Contractor shall maintain limits no less than:

1. General Liability: \$1,000,000 combined single limit per occurrence for comprehensive

coverage including bodily injury, personal injury and property damage for premises/operations, products/completed operations, contractual liability, independent contractors, broad-from property damage, and underground, explosion and collapse hazard.

2. Automobile Liability: \$1,000,000 combined single limit per accident for bodily injury and property damage including all owned, hired, and non-owned.

3. Workers' Compensation and Employers Liability: Workers' Compensation limits as required by the Labor code of the State of Georgia and Employers Liability of \$100,000 per accident.

4. Umbrella Liability: \$5,000,000 combined single limits per occurrence.

5. Builders Risk Insurance, if applicable: All Risk coverage on any buildings, structure of work and material in an amount equal to 100 per cent of the value of the contract. Coverage is to cover Cobb County interest and Cobb County shall be named as Loss Payee.

B. DEDUCTIBLES AND SELF-INSURED RETENTION

Any deductibles or self-insurance retentions must be declared to and approved by the Owner. At the option of the Owner, either: The insurer shall reduce or eliminate such deductibles or self-insured retentions as respects the Owner, its officers officials, and employees; or the Contractor shall procure a bond guaranteeing payment of losses related to investigations, claim administration and defense expenses.

C. OTHER INSURANCE PROVISIONS

1. General Liability, Automobile Liability, and Umbrella Liability Coverages.

The Owner and its officers, officials, employees and volunteers are to be covered as additional insureds as respects: liability arising out of activities performed by or on behalf of the Contractor.

Any failure to comply with reporting provisions of the policies shall not affect coverage provided to the Owner and its officers, officials, employees and volunteers.

The Contractor is responsible for insuring its own property and equipment.

2. Workers' Compensation and Employers Liability Coverage. The insurer shall agree to waive all rights of subrogation against the Owner and its officers, officials, employees and volunteers for losses arising from the work performed by the Contractor for the Owner.

3. All Coverages: Each insurance policy required by this clause shall be endorsed to state that coverage shall not be changed, cancelled, suspended, terminated or non-renewed except after sixty (60) days prior written notice by certified mail, return receipt requested, has been given to Cobb County of said change of coverage, cancellation, suspension, termination / or non-renewal.

D. ACCEPTABILITY.

Insurance is to be placed with insurers with a Best's rating of no less than A: VII, or otherwise acceptable to the Owner.

E. VERIFICATION OF COVERAGE.

Contractor shall furnish the Owner with certificates of insurance and with original endorsements effecting coverage required by this clause. These certificates and endorsements for each insurance policy are to be signed by a person authorized by that insurer to bind coverage on its behalf. The certificates and endorsements are to be received and approved by the Owner before any work commences. The Owner reserves the right to require complete, certified copies of all required insurance policies at any time.

F. SUBCONTRACTORS

Subcontractor means one not in the employment of the Contractor who is performing all or part of the services under this Agreement under a separate contract with the Contractor.

Contractor shall include all subcontractors as an additional insured under its insurance or shall ensure that subcontractors have met the insurance requirements of this agreement. Owner may request evidence of subcontractor's insurance.

Contractor is responsible for having all subcontractors comply with all terms and conditions of the Invitation to Bid.

G. WAIVER OF SUBROGATION

Vendor shall require all insurance policies in any way related to the work and secured and maintained by Vendor to include clauses stating each underwriter shall waive all rights of recovery, under subrogation or otherwise, against Customer. Vendor shall require of subcontractors, by appropriate written agreements, similar waivers each in favor of all parties enumerated in this section.

X. Award

Award will be made to the lowest responsive and responsible bidder. Conditional bids are not be acceptable. The quality of articles to be supplied, their conformity with the specifications, their suitability to the requirements of the County, and the delivery terms will be taken into consideration in making the award. The County may make such investigations as it deems necessary to determine the ability of the bidder to perform, and the bidder shall furnish to the County all such information and data for this purpose as the County may request. The County reserves the right to reject any bid if the evidence submitted by, or investigation of such bidder fails to satisfy the County that such bidder is properly qualified to carry out the obligations of the contract. The County reserves the right to reject or accept any or all bids and to waive technicalities, informalities, and minor irregularities in bids received.

The Bidder does not have the exclusive right to fill all of the County's requirements for the

goods or services awarded nor will the County be obligated to purchase the estimated annual quantity or any quantity contained in the bid document.

The County reserves the right to make an award as deemed in its best interest, which may include awarding a bid to a single bidder or multiple bidders; or to award the whole bid, only part of the bid, or none of the bid to single or multiple bidders, based on its sole discretion of its best interest. In case of tie bid, the award will be made as follows:

- 1. The bid will be awarded to the in-county vendor.
- 2. The bid will be awarded to the in-state vendor.
- 3. The bid will be awarded to the vendor with the lesser total dollar volume.

The County reserves the right to award by line item to more than one vendor. The County reserves the right to negotiate a lower price than the bid award price on any line item with the successful vendor, should the quantity required significantly exceed those on the Invitation to Bid. If the County is unable to negotiate an acceptable price, it reserves the right to rebid the item(s) involved. If after the award of the bid there is a decrease in the price of a product from the manufacturer, or a rebate, the successful bidder will pass that price decrease and/or rebate onto the County.

Time payment discounts will be considered in arriving at net prices and in award of bids. Offers of discount for payment within ten (10) days following the end of the month are preferred.

XI. Delivery Failures

Failure of a contractor to deliver within the time specified or within reasonable time as interpreted by the Purchasing Director, or failure to make replacement of rejected articles/services when so requested, immediately or as directed by the Purchasing Director, shall constitute authority for the Purchasing Director to purchase in the open market articles/services of comparable grade to replace the articles/services rejected or not delivered. On all such purchases, the contractor shall reimburse the County within a reasonable time specified by the Purchasing Director for any expense incurred in excess of contract prices, or the County shall have the right to deduct such amount from monies owed the defaulting contractor. Alternatively, the County may penalize the contractor one percent (1%) per day for a period of up to ten (10) days for each day that delivery or replacement is late. Should public necessity demand it, the County reserves the right to use or consume articles delivered which are substandard in quality, subject to an adjustment in price to be determined by the Purchasing Director.

XII. County Furnished Property

No material, labor or facilities will be furnished by the County unless so provided in the invitation to bid.

XIII. Reject And Withdraw Bids

Failure to observe any of the instructions or conditions in this invitation to bid may constitute grounds for rejection of bid.

XIV. Contract

Each bid is received with the understanding that the acceptance in writing by the County of the offer to furnish any or all commodities or services described therein shall constitute a contract between the bidder and the County which shall bind the bidder on his part to furnish and deliver the articles quoted at the prices stated in accordance with the conditions of said accepted bid. The County, on its part, may order from such contractor, except for cause beyond reasonable control, and to pay for, at the agreed prices, all articles specified and delivered. Payment terms are net thirty (30) days after receipt of invoice.

The Price and all unit prices shown shall be deemed to include all costs of Contractor's performance of the Work as set forth in the Bid Documents, including, but not limited to, the costs of labor, supervision, travel, services, materials, equipment, tools, scaffolds, hoisting, transportation, storage, insurance and taxes.

Upon receipt of a bid package, containing a Cobb County "Sample Contract" as part of the requirements, it is understood that the bidder has reviewed the documents with the understanding that Cobb County requires all agreements between the parties must be entered into via this document. If any exceptions are taken to any part, each must be stated in detail and submitted as part of the bid. If no exceptions are stated, it is assumed that the bidder fully agrees to the provisions contained in the "Sample Contract" in its entirety. The County reserves the right to make alterations to Sample contracts.

XV. Non-Collusion

By submission of a bid, the vendor certifies, under penalty of perjury, that to the best of its knowledge and belief:

- (a) The prices in the proposal have been arrived at independently without collusion, consultation, communications, or agreement, for the purpose of restricting competition, as to any matter relating to such prices with any other vendor or with any competitor.
- (b) Unless otherwise required by law, the prices which have been quoted in the proposal have not been knowingly disclosed by the vendor prior to opening, directly or indirectly, to any other vendor or to any competitor.
- (c) No attempt has been made, or will be made, by the vendor to induce any other person, partnership or corporation to submit or not to submit a proposal for the purpose of restricting competition.

Collusions and fraud in bid preparation shall be reported to the State of Georgia Attorney General and the United States Justice Department.

XVI. Conflict of Interest, Etc.

By submission of a bid, the responding firm certifies, under penalty of perjury, that to the best of its knowledge and belief:

- 1. No circumstances exist which cause a Conflict of Interest in performing the services required by this ITB, and
- 2. That no employee of the County, nor any member thereof, not any public agency or

official affected by this ITB, has any pecuniary interest in the business of the responding firm or his sub-consultant(s) has any interest that would conflict in any manner or degree with the performance related to this ITB.

By submission of a bid, the vendor certifies under penalty of perjury, that to the best of its knowledge and belief:

- (a) The prices in the bid have been arrived at independently without collusion, consultation, communications, or agreement, for the purpose of restricting competition, as to any matter relating to such prices with any other vendor or with any competitor.
- (b) Unless otherwise required by law, the prices which have been quoted in the bid have not knowingly been disclosed by the vendor prior to opening, directly or indirectly, to any other vendor or competitor.
- (c) No attempt has been made, or will be made, by the vendor to induce any other person, partnership or cooperation to submit or not to submit a bid for the purpose of restricting competition.

For any breach or violation of this provision, the County shall have the right to terminate any related contract or agreement without liability and at its discretion to deduct from the price, or otherwise recover, the full amount of such fee, commission, percentage, gift, payment or consideration.

The successful responding firm shall require each of its sub-consultant(s) to sign a statement certifying to and agreeing to comply with the terms of the Sub-sections above.

XVII. Default

The contract may be cancelled or annulled by the Purchasing Director in whole or in part by written notice of default to the contractor upon non-performance or violation of contract terms. An award may be made to the next low responsive and responsible bidder, or articles specified may be purchased on the open market similar to those so terminated. In either event, the defaulting contractor (or his surety) shall be liable to the County for costs to the County in excess of the defaulted contract prices; provided, however, that the contractor shall continue the performance of this contract to the extent not terminated under the provisions of this clause. Failure of the contractor to deliver materials or services within the time stipulated on his bid, unless extending in writing by the Purchasing Director, shall constitute contract default.

XVIII. Disputes

Except as otherwise provided in the contract documents, any dispute concerning a question of fact arising under the contract which is not disposed of shall be decided after a hearing by the Purchasing Director, who shall reduce his/her decision to writing and mail or otherwise furnish a copy thereof to the contractor. The decision of the Purchasing Director shall be final and binding; however, the contractor shall have the right to appeal said decision to a court of competent jurisdiction.

XIX. Substitutions

Bidders offering and quoting on substitutions or who are deviating from the attached specifications shall list such deviations on a separate sheet to be submitted with their bid. The absence of such a substitution list shall indicate that the bidder has taken no exception to the specifications contained herein.

XX. Ineligible Bidders

The County may choose not to accept the bid of a bidder who is in default on the payment of taxes, licenses, or other monies due to the County. Failure to respond three (3) consecutive times for any given commodity/service may result in removal from the supplier list under that commodity/service.

XXI. Alterations of Documents

Alterations of County documents are strictly prohibited and will result in automatic disqualification of the firm's solicitation response. If there are "exceptions" or comments to any of the solicitation requirements or other language, then the firm may make notes to those areas, but may not materially alter any document language.

XXII. Termination for Convenience

The County, by written notice, may terminate this contract, in whole or in part, when it is in the County's interest. If this contract is terminated, the County shall be liable only for goods or services delivered or accepted. The County Notice of Termination may provide the contractor thirty (30) days prior notice before it becomes effective. However, at the County's sole option a termination of convenience may be effective immediately and may apply to delivery orders (if applicable) or to the contract in whole.

XXIII. Inter-governmental Agreement

Other cities and Authorities located in Cobb County will be allowed to purchase identical items at the same price and upon the same terms and conditions, pursuant to the Intergovernmental Cooperative Purchasing Agreements entered into between the BOC and Cobb County Governmental entities listed under the Intergovernmental Cooperative Purchasing Program. These entities include the Cobb County Board of Education and Cities of Acworth, Austell, Kennesaw, Smyrna, Marietta, and Powder Springs and the Cobb County-Marietta Water Authority and the Cobb-Marietta Coliseum and Exhibit Hall Authority.

XXIV. Indemnification and Hold Harmless

By submission of a bid, the selected responding firm agrees to the fullest extent permitted by law to indemnify Cobb County and protect, defend, indemnify and hold harmless Cobb County, its officers, officials, employees and volunteers from and against all claims, actions, liabilities, losses (including economic losses), or costs arising out of any actual or alleged a) bodily injury, sickness, disease, or death; or injury to or destruction of tangible property including the loss of use resulting there from; or any other damage or loss arising out of or resulting claims resulting

in whole or part from any actual or alleged act or omission of the responding firm, subconsultant, anyone directly or indirectly employed by any firm or sub-consultant; or anyone for whose acts any of them may be liable in the performance of work; b) violation of any law, statute, ordinance, governmental administrative order, rule, regulation, or infringements of patent rights or other intellectual property rights by the responding firm in the performance of work; or c) liens, claims or actions made by the responding firm or other party performing the work, as approved by Cobb County. The indemnification obligations herein shall not be limited by any limitation on the amount, type of damages, compensation, or benefits payable by or for the responding firm or its sub-consultant(s), as approved by the County, under workers' compensation acts, disability benefit acts, other employee benefit acts, or any statutory bar or insurance.

XXV. Special Terms and Conditions

Should these General Terms and Conditions be in conflict with any attached Special Terms and Conditions, the Special Terms and Conditions will control.

XXVI. Disadvantaged Business Enterprises (DBE): The following provisions should be carefully read to determine applicability to your business.

Cobb County Government encourages the participation of all businesses in offering their services and/or products. It is the goal of Cobb County Government to fairly and competitively procure the best product at the most reasonable cost.

A Disadvantaged Business Enterprise (DBE) is generally defined as a Female, Black American, Hispanic American and any other minority owned business. The Federal Government has long had program in place to ensure participation of DBE vendors and suppliers. The State of Georgia has established a similar program whereby DBE firms are defined, certified and made known. This effort is managed by the Georgia Department of Transportation (GDOT). - 1. Cobb County wishes to identify <u>all</u> DBE participation; both at the contractor and subcontractor levels in the following ways.
 - a. DBE businesses are requested to identify such status at the time they register as a vendor.
 - b. DBE businesses are requested to identify themselves at the time they propose to do business. Please complete **EXHIBIT B** if applicable and return with bid submittal.
 - c. All businesses will receive with each Purchase Order an instruction sheet for use of the furnished *Cobb County Government DBE Participation Report*, **EXHIBIT C.** Businesses are requested to complete this report and submit it with each invoice for the time period billed.

2. Cobb County has established a <u>Disadvantaged Business Enterprise Plan</u> in accordance with the regulations of the U.S. Department of Transportation (U. S. Department of Transportation (USDOT), 49 CFR Part 26.) The Cobb County Department of Transportation is the lead agency for implementing the USDOT DBE Program for the County.

The <u>Plan</u> applies only to projects which are clearly indicated by the County.

Compliance with Georgia Security and Immigration Compliance Act PROCEDURES & REQUIREMENTS (Effective 10-28-2010 - Supersedes All Previous Versions)

BACKGROUND

Pursuant to the "Georgia Security and Immigration Compliance Act," Cobb County cannot enter into a contract for the physical performance of services unless the contractor registers and participates in the federal work authorization program to verify information of all newly hired employees or subcontractors. Neither may any contractor or subcontractor enter a contract with the county in connection with the physical performance of services unless the contractor and/or subcontractor registers and participates in the federal work authorization program to verify information of all new employees. O.C.G.A. § 13-10-91.

Before any bid for the physical performance of services is considered, the bid must include a signed, notarized affidavit from the contractor attesting to the following: (1) the affiant has registered with and is authorized to use the federal work authorization program; (2) the user ID number and date of authorization for the affiant; and (3) the affiant is using and will continue to use the federal work authorization program throughout the contract period. O.C.G.A. § 13-10-91 (b) (1). Affidavits shall be maintained for five years from the date of receipt. O.C.G.A. § 13-10-91 (b) (1).

Upon contracting with a new subcontractor, a contractor or subcontractor shall, as a condition of the contract or subcontract, provide Cobb County with notice of the identity of any and all subsequent subcontractors hired or contracted by that contractor or subcontractor within five (5) business days of entering into a contract or agreement for hire with any subcontractor. Such notice shall include an affidavit including the subcontractor's name, address, user ID number, and date of authorization to use the federal work authorization program. O.C.G.A. § 13-10-91 (b) (3).

Based upon the County's experience and desire for full compliance, no work may be commenced by any subsequent subcontractor prior to notice being received by the County that the subcontractor (regardless of tier) is in compliance with the law and the attached Procedures & Requirements, including the preparation and submission of the Contractor (or Subcontractor) Affidavit & Agreement AND the Immigration Compliance Certificate PRIOR to the commencement of any work.

DEFINITIONS

Affidavit – a written statement made or taken under oath before an officer of the court or a notary public or other person who duly has been authorized so to act.

Affiant – the person who makes and subscribes to a statement made under oath (affidavit).

Physical Performance of Services – the building, altering, repairing, improving, or demolishing of any public structure or building or other public improvements of any kind to public real property, including the construction, reconstruction, or maintenance of all or part of a public road; or any other performance of labor for a public employer under a contract or other bidding process.

PROCEDURES & REQUIREMENTS

- 1. <u>Bid Documents:</u> Bid documents should contain information regarding the contract language and contractual requirements described below.
- 2. <u>Responsive Bid Documents</u>: Responsive bid documents <u>MUST INCLUDE</u> a signed, notarized affidavit from the contractor in the form attached as EXHIBIT A (CONTRACTOR AFFIDAVIT & AGREEMENT). If the affidavit is not submitted <u>at the</u> <u>time of the bid</u>, the applicant will be <u>disqualified</u>.

<u>THIS AFFIDAVIT MUST BE SIGNED, NOTARIZED AND SUBMITTED WITH ANY BID REQUIRING THE</u> <u>PERFORMANCE OF PHYSICAL SERVICES. IF THE AFFIDAVIT IS NOT SUBMITTED AT THE TIME OF THE</u> BID, THE BID WILL BE DETERMINED TO BE NON-RESPONSIVE AND WILL BE DISOUALIFIED.

- 3. <u>Contract Language & Contractual Requirements:</u> Affirmative language shall be contained in agreements for the performance of services to cover all statutory and County requirements; such language shall require:
 - (a) That affidavits in the form attached to these "Procedures & Requirements" be executed from a contractor (and any subcontractors, regardless of tier) and notarized, showing compliance with the requirements of O.C.G.A. § 13-10-91 and that such be made part of the contract and/or subcontracts;
 - (b) That the contractor (and any subcontractors, regardless of tier) fully comply with the requirements for completing and submitting the "Immigration Compliance Certification" and that such certification be received by the County prior to the commencement of any work under the contract or subcontract;
 - (c) That the contractor (or any subcontractor, regardless of tier) notify the County within five (5) business days of entering into a contract or other agreement for hire with any subcontractor(s), regardless of tier;
 - (d) That the contractor be responsible for obtaining and providing to the County the "Subcontractor Affidavit & Agreement" and "Immigration Compliance Certification" attached to and required under these "Procedures & Requirements" from each subcontractor, regardless of tier, employed or retained for work under the contract prior to the commencement of any work under the contract or any subcontract;
 - (e) That Cobb County, Georgia, reserves the right to dismiss, or require the dismissal of, any contractor or subcontractor for failing to provide the required affidavit or certification and/or for failure to comply with the statutory requirements of O.C.G.A. § 13-10-91 and/or for providing false or misleading information upon the required affidavit(s) or certification(s);
 - (f) That any contractor and/or subcontractor retaining any other subcontractor to perform services under the contract provide legal notice to any subcontractor of the requirements of Cobb County for immigration compliance and further provide notice that Cobb County, Georgia, reserves the right to dismiss, or require the dismissal of, any contractor or subcontractor for failing to provide the required affidavit or certification and/or for failure to comply with the statutory requirements of O.C.G.A. § 13-10-91 and/or for providing false or misleading information upon the required affidavit(s) or certification(s);
 - (g) That failure to comply with any of the requirements and procedures of the County (i.e., failure to timely supply required affidavits or compliance certification documents;

failure to utilize federal work authorization procedures; failure to permit or facilitate audits or reviews of records by County or State officials upon request; and/or failure to continue to meet any of the statutory or County obligations during the life of the contract) shall constitute a material breach of the agreement and shall entitle the County to dismiss any general contractor or to require the dismissal of any subcontractor or sub/subcontractor (irrespective of tier) for failing to fully comply with these requirements;

- (h) That upon notice of a material breach of these provisions, the contractor (or subcontractor, regardless of tier) shall be entitled to cure the breach within ten (10) days and provide evidence of such cure. Should the breach not be cured, the County shall be entitled to all available remedies, including termination of the contract, the requirement that a subcontractor be dismissed from performing work under the contract, and any and all damages permissible by law.
- 4. <u>Immigration Compliance Certification:</u> Prior to commencing work under any contract for the physical performance of services, the contractor shall complete the "IMMIGRATION COMPLIANCE CERTIFICATION" form attached to these "Procedures & Requirements" and submit the same to the County.

Prior to allowing any other subcontractor to perform work under the contract, the contractor shall obtain a completed "IMMIGRATION COMPLIANCE CERTIFICATION" from each subcontractor (regardless of tier) and submit the same to the County.
