Questions Submitted in Writing for Clarification

Question: We are currently licensed @ 1920 Royal Industrial Blvd, Austell, GA 30168. We have leased a lot at 2975 Angelette Dr, Austell, Ga 30168. We have confirmed with Cobb County that the lot is zoned Heavy Industrial, however, we have to apply for special land use permit which will not be approved until May 2012. Can you tell me if we submit all this information with our application can we still be considered for the contract? When does the current contract expire? When does the new contract come into effect?

Answer: You would not be considered. At the time you submit your bid packet, you are submitting all information is correct and meets the requirements set forth in Qualifications. The current contract expires mid-night April 17, 2012. The new contract will go into effect on April 18, 2012 at 12:01 a.m.

Question: In reviewing the information for this bid (12-5635), it requires that a signed, notarized credit history release be provided. I did not see such a form in the bid package. Should we create one ourselves? Regarding Exhibit A, for this particular county contract we are not allowed to hire subcontractors. Should we sign Exhibit A-1 if we do not hire subcontractors?

Answer: The credit history release form is a document that can be created by the bidder. It should include a general statement giving authorization for the credit history check along with the signature of the bidder. It can be done on letterhead of the company so that it includes the business address and contact information.

No, Exhibit A-1 is not required to be signed, or required to be submitted with your bid. However, Exhibit A is required to be submitted with your bid.
