

REQUEST FOR QUALIFICATIONS

2012 STORMWATER MANAGEMENT UNIT-PRICE AGREEMENT PROGRAM NUMBER: 2012-SWM-UPA FOR THE COBB COUNTY BOARD OF COMMISSIONERS

Notice is hereby given that the Cobb County Water System, Stormwater Management Division (Stormwater Management), on behalf of the Cobb County Board of Commissioners (Owner), has determined that all contractors intending to submit proposals for the **2012 Stormwater Management Unit-Price Agreement (2012 SWM UPA)** must be pre-qualified. The intent of the **2012 SWM UPA** is to have available for Cobb County's use, Contractors to provide for construction of certain items of work at any location within Cobb County when needed.

Pre-qualification Applications from contractors interested in performing projects under the 2012 SWM UPA will be received by the Owner at the offices of the **Cobb County Purchasing Department (Purchasing Department), 1772 County Services Parkway, Marietta, Georgia 30008**, until **12:00 noon** (local time) on **Thursday, March 22, 2012** using the Pre-qualification Application packet provided by Stormwater Management. The project name and project number must be shown on the outside of the envelope. **No applications will be accepted after the aforementioned submittal deadline.** Applications received after the submittal deadline will be returned to the applicant unopened.

The Pre-qualification Application packet (the Application Packet) is available for a non-refundable fee of **\$10.00** payable by check or money order at the office of **Cobb County Water System, Stormwater Management Division, Building No. 2, 680 South Cobb Drive, Marietta, Georgia 30060-3113.**

Application packets may be submitted during regular operation hours on any day that the offices of the Purchasing Department are open for business. The Application Packet must be completed in accordance with the **Instructions** section of the Application Packet and accompanied by a FAX number in order to notify the applicant of the acceptability or non-acceptability of his/hers qualifications. If any information provided by the applicant becomes inaccurate, the applicant must immediately notify Stormwater Management and provide updated, accurate information in writing.

Application packets will be opened at **2:00 p.m.** (local time) on the submittal deadline day in the **Bid Room** of the **Purchasing Department, 1772 County Services Parkway, Marietta, Georgia 30008.** Applications will be accepted only from applicants who are listed on the Application Packet Holders List, signifying that they have obtained an Application Packet from Stormwater Management.

It is the intent of the pre-qualification process to assist Stormwater Management in determining Contractors who have the necessary technical and managerial skills, financial capacity, and integrity to satisfactorily undertake and complete individual projects under the 2012 SWM UPA.

However, neither the fact of pre-qualification, nor any pre-qualification rating, will preclude Stormwater Management from a post-proposal consideration and determination of whether a contractor is the “low responsive, responsible contractor” for an individual project performed under the 2012 SWM UPA.

This is not an **Invitation to Bid**. No guarantees express or implied, are made that the 2012 SWM UPA will be awarded, or that any projects will be constructed at all. Owner reserves the right to revise, change, modify, or delete the 2012 SWM UPA scope or schedule.

Cobb County reserves the right to reject any application not submitted within the required time frame; reject any non-responsive (incomplete) application submitted; contact references supplied; require additional information; and/or require interviews with any responding applicant. The applicant accepts all risk and costs associated with the completion of the prequalification application packet.
