Questions Submitted in Writing

1. As pricing is firm for 24 months and the lifecycle of an asset is several years, does the County wish to see price options for 802.11n Access Points, either in place of (or in addition to) the requested AP 1131 (AP 1142) and AP 1242 (AP 1252) devices?

ANSWER - Pricing can be included for these devices on the attached Revised Bid Form, BUT responder must quote items specified in bid package

2. For the 1242 Access Point configuration in the RFP, an antenna was not listed. Does the County desire to have vendors include an antenna with this device?

ANSWER - Antennas do not need to be bid.

3. As pricing is firm for 24 months and the lifecycle of an asset is several years, does the County wish to see price options for 10/100/1000 3560 switching, either instead of (or in addition to) the requested 10/100 3560 configuration?

ANSWER - Pricing can be included for these devices in an addendum, BUT responder must quote items specified in bid package

4. For the 3845 Voice Gateway(s), a few items are different on the current devices than specified in the RFP. The 3845 now comes standard with 128F and 512D memory. Based on this change in the base unit, does the County wish to change any of the requested memory upgrade options? For reference, a sample of configuration options is provided below--based on the requirements in the RFP and current system configuration options.

- For the VG248, this device does not allow for any configurable options (other than a power cord); the memory options for the Analog Gateway are for a VG224, does the County wish to change the VG248 to VG224 and add these options, or should the vendor remove this items and quote the standard VG248?

ANSWER - If the VG248 Analog Gateway is available bid it in it's maximum memory configuration. If the VG248 Analog Gateway is no longer available, substitute the VG224 Analog Gateway and include the VG224 memory options listed in the bid document. When bidding the VG, the intent is to have a total of 96 ports. Bid accordingly
