**Questions submitted in writing**

**Question:** Can we please obtain a retiree census in excel format.

**Answer:** The census is included in the excel format as part of Addendum 1.

**Question:** Since the proposed Medicare Advantage plan will be an option for retirees, can you please provide plan designs and current rates for other plans that retirees can select(ie: PPO, EPO and OA).

**Answer:** The Retiree Side-by-Side Comparison, showing plan options, design and retiree rates for 2009 is attached.

**Question:** Please verify that the BCBS claims are for medical only and that RX is through Medco for actives and retirees.

**Answer:** The BCBS claims are medical only and all BCBS-Ga participants receive their prescription drug benefits through Medco. The current Anthem MA-PD participants receive their medical and pharmacy benefits through that plan.

**Question:** What is the current Coordination of Benefits (COB) methodology for the in-force PPO, EPO and OA plans? Please advise for each plan if COB methodology is "Come Out Whole" (aka "COB"), or "Government Exclusion" (aka "Medicare Exclusion") or "Non-Duplication" (aka "Carve Out").

**Answer:** We coordinate to the "allowed amount", would, I believe, fall into their COB or "Come Out Whole" bucket. We use our contractually allowed amount as the basis of calculation of liability.
