Questions Submitted in Writing

Question: Was this kit ever sold to the county before? If yes, what price was the prior bid awarded at?

Answer: The prior awarded price was \$0.75 per kit.

Question: I am wondering what the last agreement between the County and ICS was for the price of the inmate care packages.

Answer: The prior awarded price was \$0.75 per kit.

Question: What was the last price between the county and ICS price per unit for these care kits?

Answer: The prior awarded price was \$0.75 per kit.

Question: I am also just now getting setup as a vendor with the county, if I were to win the bid what this inhibit my ability to win the bid if I were the lowest price?

Answer: You are not required to be a registered vendor to bid. However, should you be the successful bidder, then you will be required to register your company with Cobb County.

Question: What is the current price Cobb County is paying for the inmate care kits?

Answer: The prior awarded price was \$0.75 per kit.

Question: Will the county waive the requirement on the soap as well so that bidders can bid an alternate brand for the soap as long as it is a 1.5oz unwrapped soap?

Answer: No substitutions for the soap.

Question: Can you give more detail on the cup? Do you have a manufacturer's name and part number or specification?

Answer: The cup is included in the kit, with no markings indicating manufacturer or part number. The only marking on the cup lists, "12oz".

Question: Can you tell me what the last awarded price for the kit?

Answer: The prior awarded price was \$0.75 per kit.

Question: Can we bid a FreshScent Brand soap in a 1.5 oz size instead?

Answer: No substitutions for the soap.

Question: What was the prior price for the inmate care kits?

Answer: The prior awarded price was \$0.75 per kit.

Question: Since we can substitute the brand of the toothpaste as per addendum No. 1, can we substitute the brand of the soap with a brand equal to or better than Dial as well?

Answer: No substitutions for the soap.

Question: I have received an addendum of sealed bid number 11-5549 because of the toothpaste, my request or question is, is the DIAL soap still not able to be substituted?

Answer: No substitutions for the soap.
