Questions submitted in writing

Question: I would like to bid the footwear portion of your request. I note that none of the footwear listed require blood borne protection. This requirement is something that every CO and Deputy in your department should have. I would like to bid the Haix brand which is a German made boot and does protect officers against blood borne and other chemical contaminants. You spec only Bates, which is a made in China boot and does not provide this protection. I would like to bid Haix as an equal or better.

Answer: Vendors can submit a bid on all items listed in the ITB 11-5597 in accordance with its provisions. Page one (1) of the ITB 11-5597 – BRAND NAMES states brand names are furnished for reference purposes and to establish a standard of quality. We are requesting “No Substitution” on brand or style numbers indicated in this bid for the purpose of uniformity, continuity and approved safety standards in issuance of uniform equipment to our personnel. Where substitution is permitted, the Sheriff Office shall retain sole discretion as to whether the proposed substitution is an approved alternate. Alternate brand names and models, if called for, will be considered only if identical in application, performance, quality and warranty. Bidders submitting alternate proposals must indicate brand name and model number. Manufacturer’s specification sheets shall be furnished with your bid.

The shoes, Bates Boots (approx 250/yr) (Item # 100) does not list NO SUBSTITUTION and Vendors can submit another manufacturer product provided they conform with the above specifications. Recommendation is to possibly provide a sample product with the bid submission.

Question: Rank Insignia: (Sergeant/Lieutenant/Major/Lieutenant Colonel/ Colonel/ Asst. Chief Deputy/ Chief Deputy/Sheriff). Can you provide a list of what you use for the ranks? Such as Chevrons for sergeants, bars for Lt. & Capt. Etc.
