Sealed bids will be received until **12:00 noon on December 10, 2009**, by the Board of Commissioners of Cobb County, Georgia, **at the Cobb County Purchasing Department located at 1772 County Services Parkway** in Marietta, Georgia. **NO BIDS WILL BE ACCEPTED AFTER THE 12:00 NOON DEADLINE.** Those received late will be unopened. No submitted bid may be withdrawn after the scheduled bid opening time for a period of ninety (90) days.

Bids will be opened at **2:00 p.m. on December 10, 2009, at the Cobb County Purchasing Department, 1772 County Services Parkway, Marietta, Georgia 30008.**

A prebid conference for all bidders will be held in the Cobb County DOT Conference Room, located at 1890 County Services Parkway, **at 10:00 a.m. on December 1, 2009. Any questions must be received no later than seventy-two (72) hours prior to the bid opening.**

The work to be done consists of the furnishing of all materials, labor and equipment for the complete construction of:

Project No. / Name: D6050 -- Canton Road – Phase 1

Project consists of the addition of raised concrete medians, from Rosedale Drive/Hamby Drive to north of Piedmont Road, and from Worley Drive to just north of Blackwell Road/New Chastain Road. Red stamped asphalt will be added from north of Piedmont Road to Worley Drive. Project also includes intersection improvements of Piedmont Road and Blackwell Road/New Chastain Road. Sidewalk will be added for the entire length of project.

The time allowed for performance of the project will be 270 days.

Payment will be made monthly based on approved invoices.

Cobb County Water System work is involved on this project. Only contractors or sub-contractors who have been prequalified with Cobb County Water System are allowed to perform water and sewer relocation work associated with this project. Bidders or their water/sewer subcontractor are required to have a State of Georgia Utility Contractor License.

The **Contractor** must have a valid general contractor license or a current Georgia Department of Transportation Certificate of Qualification.

For all bids on contracts involving utility work as defined in O.C.G.A. 43-14-1 et.seq., the **Contractor and/or its subcontractor(s)** that will perform utility work must have a valid State of Georgia Utility Contractor License and comply with all applicable provisions of Chapter 14 of Title 43 of O.C.G.A.
