FY2010 UNIT PRICE CONTRACT FOR MISCELLANEOUS PLUMBING SERVICES

THE BOARD OF COMMISSIONERS OF COBB COUNTY, GEORGIA

Separate, sealed bids for furnishing all materials, labor, tools, equipment, and incidentals necessary for the construction of the aforementioned project will be received by the **COBB COUNTY BOARD OF COMMISSIONERS**, herein referred to as "**Owner**", at the offices of the **Purchasing Department, 1772 County Services Parkway, Marietta, Georgia 30008**, until **12:00 Noon** (local time) on **July 23, 2009**. The project name must be shown on the outside of the bid envelope. **No bids will be accepted after the 12:00 Noon deadline.**

Bids will be opened at 2:00 PM (local time) on **July 23, 2009**, in the **Purchasing Department bid room, Purchasing Department, 1772 County Services Parkway, Marietta, Georgia 30008**.

The Project consists of the following major elements: **unit price contract for on demand miscellaneous plumbing services for the Cobb County Water System Operations & System Maintenance Division.**

All qualified contractors are invited to bid on this project; however, the Owner will adjudge qualification based on the "Bidder's Statement of Qualifications" submitted with the bid. Only those bidders deemed qualified by the Owner will be considered for award.

Prospective bidders must be aware that this contract requires that all work tasks must be performed by personnel licensed under the Georgia Construction Industry licensing Board, Division of Master and Journeyman Plumbers. It is the intent of the Cobb County Water System that this contract be awarded to qualified firms which are primarily engaged in plumbing work activities.

The names and license numbers of the individuals proposed to perform the work under this contract must be included in the "Contractor's Statement of Qualifications" (Section 00300).

The Instruction to Bidders, form of Bid, form of Contract, Specifications, and other contract documents are available for a non-refundable fee of **\$25.00** payable by check or money order at the offices of **Cobb County Water System, Engineering & Records Division, 660 South Cobb Drive, Marietta, Georgia 30060-3105**. Bids will be accepted only from Bidders who are listed on the Plan Holders List, signifying that

they have purchased a set of documents from the Cobb County Water System.

Owner reserves the right to waive any informalities or to reject any or all bids, to evaluate bids, and to accept any bid which in its opinion may be for the best interest of Owner. Any bids submitted that do not include a duplicate of Section 003 as specified in the Instructions to Bidders may be rejected. Owner has the right to add to and delete from the contract once it has been awarded. Award, if award is made, will be to all responsive, responsible bidders.

No bidder may withdraw his bid within 60 days after the actual date of the opening thereof.
