The project consists of the following major elements:

Design, permitting and construction of a facility that will be used as a municipal solid waste transfer station and recycling center by Cobb County. Project will require construction and design capabilities in civil, architectural, structural, electrical, mechanical, air quality control, fire protection, and landscaping. Work will include, but not be limited to the design and construction of the following: site grading; stormwater, erosion, and sedimentation control system; stormwater drainage control; building foundations; access roads; paved surfaces; landscaping; electrical and lighting; fire protection; building heating and cooling; MSW Transfer Station building; two parallel tunnel system for the Transfer Station; an Office Building to house Cobb County Solid Waste staff and provide multi-media education center for Keep Cobb Beautiful (KCB); a Recycling/Bailer Building; two scale houses (one inbound and one outbound); an oil/antifreeze building; utilities; and relocation of four existing scales.

Any proposals submitted that do not include a response of Section 003, a bid bond as specified in the Instructions to Offerors, and a Statement of Qualifications prepared in accordance with Section 011 <u>will</u> be rejected. Owner has the right to add to and delete from the contract once it has been awarded. Award, if award is made, will be to the most qualified and lowest responsive, responsible Offeror.

The successful Proposer for this Project will be required to furnish a satisfactory performance bond and labor and materials payment bond, each in the amount of one-hundred percent (100%) of the proposal.
