Proposals for engineering services for design of the aforementioned projects will be received by the **COBB COUNTY BOARD OF COMMISSIONERS**, herein referred to as "**Owner**", at the offices of the **Purchasing Department, 1772 County Services Parkway, Marietta, Georgia 30008**, until **12:00 Noon** (local time) on **December 15, 2011**. The project name and project number must be shown on the outside of the bid envelope. **No proposals will be accepted after the 12:00 Noon deadline.**

Proposals will be opened at 2:00 PM (local time) on **December 15, 2011**, in the **Purchasing Department bid room, Purchasing Department, 1772 County Services Parkway, Marietta, Georgia 30008**.

The Cobb County Water System intends to select three engineering firms to prepare construction documents for the replacement of existing water mains in selected areas within the county. The projects will involve the replacement of old asbestos-cement and/or PVC water mains with new ductile iron pipe mains, including new valves, fire hydrants, and customer service connections. Southeast Cobb consists of designing the water main replacements for the following areas: Gaylor Street, Independence Square S/D, Meadow Chase S/D and Murdock Road. West Cobb consists of designing the water main replacements for the following areas: Mountain Breeze Estates and Big Oaks S/D, Settendown Trail, Shannon Green Phase 2, and Stilesboro Cove S/D. Northeast Cobb consists of designing the water main replacements for the following areas; Chimney Springs Phase 1, Chimney Springs Phase 2, and Somerset Phase 2.

Proposals will be accepted only from Firms who are listed on the RFP Holders List, signifying that they have received a set of documents from the Cobb County Water System.

Owner has the right to add to and delete from the contract once it has been awarded. Respondents may submit a proposal on any or all of the three projects; however, only one project will be awarded to an individual firm.

The successful engineering firms selected for these projects will be required to furnish satisfactory certificates of insurance for general liability, automobile liability, professional liability, and worker's compensation and employers liability coverage.
